Rules:

- Any member wishing to speak shall rise, address the President, give name and state, and be recognized.
- All motions and amendments must be in writing and given to the President.
- No member shall speak more than once on a subject, or twice if the permission of the assembly is granted.
- No one subject shall be discussed longer than 5 minutes.
- Only voting members of APTA Pediatrics shall present motions, enter discussions, and vote.
- These rules shall be adopted by a qualified majority vote and may be amended by a 2/3 vote.

Founded in 1968, Special Olympics is a global movement to end discrimination against people with intellectual disabilities. Special Olympics fosters acceptance of all people through the power of sport and programming in education, health, and leadership.

Special Olympics Health programming not only benefits athletes and people with ID, but promotes inclusion in the community, through the training of health professionals and students who volunteer with the movement.

Specific opportunities that may involve pediatric populations include:

- <u>Young Athletes</u>: Early childhood sport and play program for children with and without intellectual disabilities that fosters inclusion and supports advancement in core developmental milestone through the introduction of foundational sports skills.
- <u>Healthy Athletes:</u> Free health screenings in nine disciplines tailored for people with ID, aimed to identify areas of concern, provide education, and recommend follow-up care. Includes screenings in **physical therapy and pediatrics.**
- Fitness programming: Year-round opportunties that promote healthy lifestyle behaviors in physical activity, nutrition, and hydration, and support athletes in maximizing their health and well-being.
